Message from the Chancellor of Kobe College Dr. Ken Ii

On behalf of Kobe College, I would like to extend our greetings to the 2025 Annual Meeting of KCC-JEE. I would like to take this opportunity to express our gratitude for your support over the past 100 years. I pray for God's blessings upon you and your activities.

This year, we celebrate our 150th anniversary. We are able to share this joy thanks to the participation and dedication of many people. We would also like to take this opportunity to give our thanks for God's guidance.

The Junior and Senior High School students are actively engaged in activities both inside and outside of school. They have received awards in various contests across academic fields, volunteer activities, sports, and traditional culture. It is our pleasure to support students who have high academic abilities and are also active in areas other than learning.

In the College, the number of students enrolled has reached approximately 95% of our capacity this year. I imagine that the restrictions on public relations activities for students during the pandemic caused a decrease in enrollment and raised concerns for you, but from the 2024 academic year, we have seen a recovery trend. We believe this is due to the reorganization of the faculty, improvements in the learning environment, and innovations in the entrance examination system. We will strive to further deepen this trend.

In Japan, some women's colleges have become coeducational while others have closed. In Hyogo Prefecture, where Kobe College is located, there will be only three women's colleges by 2027. Many of them are taking those actions due to various issues, but we have decided to develop our original mission of women's education.

As part of our 150th anniversary commemorative project, we are advancing campus improvements. We will hold a commemorative ceremony in October of this year and by that time repair work of the Main Gate and construction of the new school buildings on the west side will be well underway. We are grateful and delighted that a new chapter in the history of Kobe College is beginning. In addition, at the commemorative ceremony, a piece arranged by a young graduate who received the Hannah Gulick Suehiro Scholarship will be performed. We hope this will bring joy to you.

In April of this year, the Private School Law was revised, and Kobe College's Constitution (Kifukoi) was also changed. Accordingly, I completed my two-term tenure as Chairperson in June and stepped down, and Dr. Koichi Tateishi, professor of the Faculty of International Studies, was appointed as the new Chairperson. We look forward to continuing our good relationship with you in the future.

Message from the President Dr. Yuki Ohigashi

We are grateful for your continued support for the mission of Kobe College Corporation – Japan Education Exchange (KCC-JEE). Your precious gifts allow us to continue our programs. I hope this annual report communicates to you what your investment is producing.

Last fiscal year, our Board of Directors were busy reviewing the amendment of the Constitution of Kobe College (KC). The Private School Act in Japan was revised and is in effect as of April 2025. The intention of the Amendment of the Private School Act is to strengthen the governance of school management and to enhance the transparency and checks-and-balances of different parties, including Trustees, Councilors and Auditors. Private schools in Japan were required to review their constitutions and make changes accordingly. Because KCC is a constitutional partner, along with Megumi-kai (the alumni association of KC), KC's Constitution states that they are to seek our opinions when revisions are made to their Constitution. The Board of Directors spent many hours reviewing the draft of revised Constitution, held a special board meeting, and sent KC our opinions, addressing some concerns we had.

Our opinion letter to KC is available to any KCC members by contacting our office.

The educational environment surrounding KC is challenging due to lower birthrates and a declining interest in women-only schools and liberal arts education, some of which are true in the U.S. as well. As KC celebrates their 150th anniversary in 2025, we hope to work with them in planning the role of KC in today's Japan, and in the global society.

KCC is continuing to organize its historical documents by digitizing them. As reported last year, the originals of our historical documents have been donated to the University of Chicago's library. Our hope is that these documents will be available to many researchers and others who find our long history and our relationship with KC interesting.

KCC-JEE's financial position increased during fiscal year ended March 31, 2025, with an increase in its net assets of approximately \$24,000. As shown in the summarized financial results on page 5, the Organization had an overall investment gain for the year of approximately \$267,000. The Organization ended the fiscal year with a net asset balance of approximately \$4.6 million. The Organization's investment portfolio has had a strong performance for the last two fiscal years. The Organization remains reliant on strong stock market results in order to generate an increase in its net assets while maintaining its program at the current level. Although the Organization's investment portfolio is diversified to protect the overall value from significant volatility in the markets, the Finance Committee continues to monitor its performance. The Organization remains in a healthy financial position to continue its programs without interruption.

The Organization once again satisfied its 5% distribution rule as a private non-operating foundation whereby it must distribute 5% of the value of the net investment assets annually in the form of program and certain eligible administrative expenses.

The Organization received total contributions of approximately \$15,000 for the year. This includes approximately \$4,000 from KC graduates living in North America. We are most grateful for the generosity and support, which is essential for KCC-JEE to continue its programs and carry out its mission. Our most sincere "Thank you" to each and every supporter of the Organization.

The Organization's investment portfolio is managed by the investment management firm of William Blair. William Blair, founded in 1935 and based in Chicago, is a global investment banking and asset management firm. The Finance Committee has periodic meetings with the William Blair team as part of the ongoing monitoring of the investment portfolio.

To ensure future sustainability of the Organization, we remain committed to vigilant fiscal responsibility in both our spending on programs and administrative expenses while at the same time recognizing that future investment gains are not guaranteed. We as a Board will continue to exercise prudent investment policies with the intent, if possible, to produce long-term investment gains and have sufficient liquidity to appropriate funds for programs and other expenses.

The KCC-JEE Programs —Bryant Drake Guest Professorship, High School Essay Contest, Gottschalk Teacher, and Graduate Fellowship— had a successful year. In our current global climate, we remain undeterred in our commitment to providing high quality and unique programs that foster cross cultural understanding and appreciation for shared humanity.

Below you will find details of each Program. In brief summary, the Bryant Drake Guest Professor Program underwent evaluation, the High School Essay Contest selected a winning essay (Emma Taylor of Virginia) out of many excellent submissions, the Gottschalk Teacher Program successfully recruited one English teacher (Mr. Adetomiwa Oluwaseyi Ibukun Adesokan), and the Graduate Fellowship bid farewell to (now) Dr John Ostermiller (University of Nevada, Reno) and welcomed doctoral candidate Lena Paulsen (University of Minnesota) who began her research in affiliation with Kobe College in fall 2024.

We are grateful to the support that we receive for the KCCJEE Programs. We cherish our close relationship and collaboration with Kobe College that make the Programs possible.

High School Essay Contest Submitted by Cindi SturtzSreetharan

The High School Essay Contest received 22 submissions representing 9 different states. Ultimately, Emma Taylor of Virginia was selected as the 2025 Essay Contest winner. Emma began studying Japanese on her own before taking Japanese language classes at her high school. Emma will study at Genki Japanese & Culture School in Kyoto as well as do a homestay.

In October we will publish the High School essay prompt on the KCC-JEE website. Please encourage any high school students studying Japanese to think about submitting an essay. To be eligible, the applicant must be at least 16 years old by July 1, 2026.

Gottschalk Teacher Program Report Submitted by Elizabeth Hartung-Cole

The Gottschalk Teacher (GT) committee recruits, screens, and recommends high-quality English-speaking teachers for full-time teaching positions at Kobe College Junior and Senior High School (KCHS). The GTs also actively work with students in extracurricular events including English Clubs, local/national speech contests, Cultural Festival, and school trips. These efforts greatly contribute to school's well-earned national reputation for excellence, especially in English.

The 2024 Committee welcomed two new members associated with KCHS: Erin Choi (a former Gottschalk Teacher) and Linda Gosselin (a former missionary teacher). Abbi Mayland, Toyoko Kodama and I were extremely grateful for their valuable time and expertise in helping us be successful.

The 2024 GT summer recruitment for one teacher for a contract from April 2025 through March 2027 received fifty-three applications. The committee screened the initial documents which include an essay, transcripts, and teaching experience. Based on the previous year's committee recommendations, we made two modifications to the process. First, we changed the essay prompt to a topic which would be less likely to be influenced by artificial intelligence. Secondly, instead of a zoom interview of each semi-finalist, we required each to submit a recorded short self-video answering given prompts. This modification reduced the difficulties of scheduling sixteen zoom calls from a vast array of time zones and gave each committee member a more manageable way to evaluate all the videos at times which fit into their work/life schedules. The results of both modifications were positive.

In October, we were pleased to learn that Kobe College offered the contract to Mr. Adetomiwa Oluwaseyi Ibukun Adesokan, highly recommended by the committee, who accepted the offer. Adetomiwa Oluwaseyi Ibukun Adesokan has a B.A. in English and secondary education from Salisbury University, Maryland and a secondary teaching credential from the state of Maryland. He has taught in Maryland public schools for five years and in the JET program in Shizuoka for two years. He is deeply interested in Japanese culture and language. He is very professional and kind with a delightful sense of humor. He looks forward to sharing not only his own American culture but also his Nigerian cultural background to help students learn about a variety of other cultures.

Bryant Drake Guest Professorship Submitted by Cindi SturtzSreetharan

This past year was an off-cycle of the BDGP and we look forward to recruiting the next BDGP to begin in April 2026.

During 2024 – 2025, under the leadership of Board Member Toyoko Kodama and in conjunction with Kobe College, the Bryant Drake Guest Professor Program was evaluated. We learned that the Program provides unique opportunities for learning and collaboration among Kobe College staff, students, and faculty as well as to the visiting professor. We also came to understand the

challenges that arise for all people involved in these kinds of programs. We remain deeply committed to the BDGP and the opportunity to contribute to building cross cultural understandings and empathy.

KCC-JEE Graduate Fellowship Program Submitted by Liv Coleman

Relevance to the Mission

The Graduate Fellowship Program is a nationally distinctive fellowship program awarding one fellowship valued at \$30,000 per year for doctoral dissertation research in Japan. Applicants are selected through a competitive application process. Graduate Fellows may select Kobe College as a research affiliation site and several fellows have done so. All Graduate Fellows make a research presentation at Kobe College during their time in Japan. Graduate Fellows make contributions to the US-Japan relationship and intercultural understanding not only through their intellectual research contributions, but also through their career development into college and university educators about Japan, bringing their specialized knowledge of Japan to generations of students and the public audiences around their universities.

Efficiency

The Graduate Fellowship Program operates within the allocated budget. For transparency and efficiency purposes, the program publicizes due dates for applications, advertises the program widely, and communicates the names and project titles of fellowship winners. We also receive a mid-year report from the fellowship winner each year to hear about their research progress in Japan. We ask that Graduate Fellows who publish research based on their work funded by this fellowship include a statement mentioning our support in their publication.

Outcomes

The Graduate Fellowship Program facilitates research in Japanese Studies that in many cases simply may not otherwise be possible, given the relatively small number of opportunities available for doctoral students to apply for funds supporting international travel and research abroad. This kind of financial support for doctoral research in Japan launches careers in Japanese Studies that last lifetimes and offers funds for which there are no ready substitutes. The knowledge gained, new scholarship generated, and professional networks built are the very backbone on which US-Japan relations are built at the level of civil society. Graduate Fellows frequently report that KCC-JEE Graduate Fellowship support is career-making and life-affirming.

Sustainability

The Graduate Fellowship Program's fundraising is part of the overall fundraising program of the KCC-Japan Education Exchange. The program is also open to earmarked contributions from those who want to ensure its future. To ensure the sustained quality of our program and make sure it works as smoothly as possible, the program seeks feedback from Graduate Fellowship recipients through their mid-year progress reports to the organization and by open email communication with fellows throughout the year about how the travel arrangements and research experience are going. Fellows are often invited back to KCC-JEE events to give presentations on their research and chat about their experiences as well.

Current (and Past) Graduate Fellowship Recipients

Our current 2024-2025 Graduate Fellow is Ms. Elena ("Lena") Paulsen, a Ph.D. candidate in the History Department at the University of Minnesota. Her project is titled, "Shojo Modernity: Queer Girlhood and Tuberculosis in Early Twentieth Century Japan," and she is affiliated with Kobe College.
